5. Every year many people are getting of their health insurance coverage through us. So far we have helped a lot of people to get insured of Rs.5 Crores for their treatment.

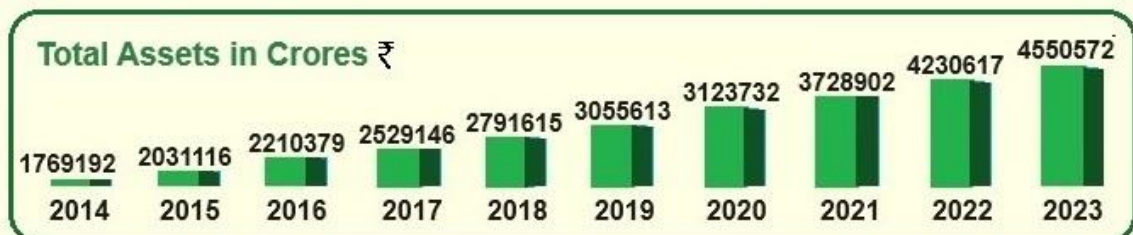
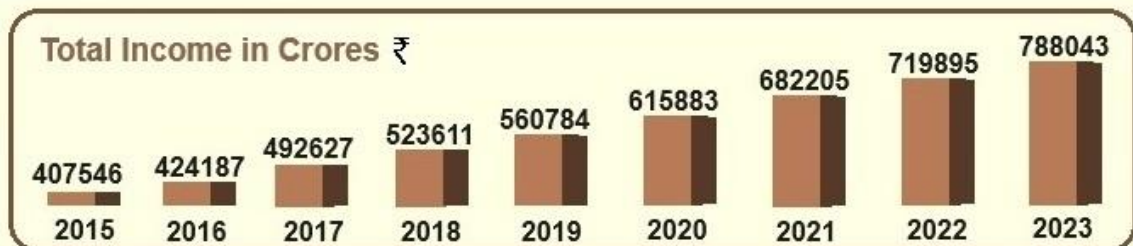

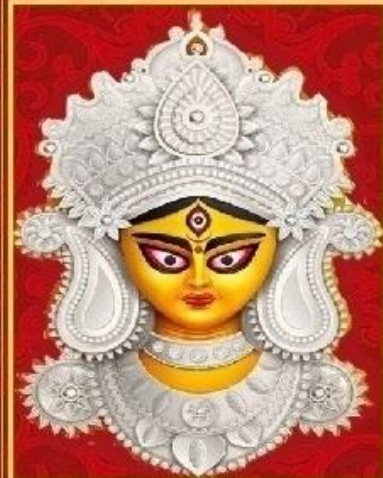
